(Sept. 15) Commissioners approved the draft minutes of the July 28 conference call.

3. SEMI-ANNUAL MEETING AGENDA

(Sept. 15) Commissioners reviewed a draft agenda for the October 27-31, 2008, Semi-Annual meeting and approved it with edits.

5. LAKE ONTARIO - ST. LAWRENCE RIVER (LOSLR)

- . (Sept. 15) Commissioners reviewed and commented on draft media guidance to address inquiries related to the September 4, 2008 IJC letter to governments on LOSLR and agreed that it should be revised based on their comments.
- A. (Sept. 15) Commissioners reviewed the September 3, 2008 letter from the Province of Ontario in which Minister of Natural Resources Canfield provided its position on Lake Ontario - St. Lawrence River regulation and agreed it should be posted along with other comments on the IJC website.
- B. (Sept. 15) Commissioners reviewed and approved a draft rapid communications policy on LOSLR issues when quick turnaround is needed.
- C. (Sept. 15 and 19) Commissioners reviewed draft Terms of Reference (TOR) to establish an International Lake Ontario - St. Lawrence River Working Group with the Governments of Canada, the United States, the State of New York, and the Provinces of Ontario and Quebec and asked that a revised draft be prepared. The proposed group would provide advice to the Commission on issues of mitigation and adaptive management measures that would, when combined with an IJC Order of Approval and regulation plan developed

by the Commission, meet a revised set of goals, objectives and criteria in the Order. (Subsequently Commissioners approved a final draft of the TOR and provided it to the U.S. State Department and Canadian Department of Foreign Affairs and International Trade on September 22, 2008).

6. INTERNATIONAL MISSISQUOI BAY STUDY BOARD

- . (Sept. 15) Commissioners approved the following appointments to the International Missisquoi Bay Study Board: U.S. members Mr. Erik Beck and Mr. Eric Smeltzer; and Canadian member Mr. Daniel Leblanc. Commissioners also approved the draft Directive to the Board.
- A. (Sept. 19) Canadian Secretary Clamen and U.S. Adviser Brakel briefed Commissioners on their participation in the Lake Champlain Basin Program Steering Committee meeting that was held in West Brome, Quebec September 9-10, 2008.

7. INTERNATIONAL UPPER GREAT LAKES STUDY

(Sept. 19) Commissioners reviewed letters from the Georgian Bay Association Foundation and the National Wildlife Federation concerning the International Upper Great Lakes Study and provided guidance on a response.

8. BOUNDARY WATERS TREATY CENTENNIAL SYMPOSIUM

(Sept. 15) Commissioners discussed an invitation they each received to participate in a Boundary Waters Treaty Centennial Symposium to be co-hosted by Wayne State University and the University of Windsor in February 2009. Commissioners agreed that their participation would be useful and requested that the details be worked out with the Symposium organizers and reported back to Commissioners.

9. INTERNATIONAL WORKSHOP ON "INSTITUTIONAL CAPACITY DEVELOPMENT IN TRANSBOUNDARY BASINS: LESSONS LEARNED FROM PRACTICAL EXPERIENCES"

(Sept. 19) Commissioners reviewed the invitation from organizers of an international workshop on "Institutional Capacity Development in Transboundary Basins" to be held in Bonn, Germany in November 2008 and approved the participation of one IJC staff member and asked Secretaries to recommend who should participate.

10. U.S. Institute of Medicine (IOM) Evaluation of Agency for Toxic Substances and Disease Registry (ATSDR) Report

(Sept. 19) Commissioners received a briefing on the history of the ATSDR report, originally requested by the IJC in 2001, and approved draft media guidance and the recommendation to send a letter to the Centres for Disease Control (CDC) of the ATSDR urging release of the report.

11. INTERNATIONAL ST. LAWRENCE RIVER BOARD OF CONTROL (ISLRBC)

(Sept. 19) Commissioners reviewed a letter from the International Water Level Coalition concerning membership on the ISLRBC and approved a draft response.

12. OTHER BUSINESS

A. Dredging in St. Marys River

(Sept. 19) Commissioners received an oral report on the status of dredging done by the Essar Steel Algoma Inc. in the upper St. Marys River and agreed the matter should be raised at the meeting with governments at the October semiannual meetings.
