1. Commissioners approved the agenda with the addition of three items under Other Business.

# **MINUTES**

2. Commissioners approved the draft Minutes of the Commissioners' Executive Meeting of October 27-29, 2009, and the Conference Calls of October 23, 2009, and November 13, 2009.

## **BRING-FORWARD SYSTEM**

3. Commissioners noted no outstanding letters requiring a response to the Commission or outstanding letters requiring a reply from the Commission.

#### INTERNATIONAL UPPER GREAT LAKES STUDY

4. Commissioners received an oral report on the IUGLS Peer Review material and agreed that authority be delegated to the Engineering Advisers. As liaisons to the IUGLS, to Engineering Advisers may approve posting of material associated with the IUGLS pertaining to the independent peer review process, such as peer review reports, responses by the authors of the reports and the reports. Commissioners agreed that a more formal delegation protocol may be developed but that release of the IUGLS reports should not wait on a formal protocol of guidance. Staff and Legal Advisers were directed to draft appropriate language if needed for posting a note on the website indicating certain IUGLS reports were pending.

#### INTERNATIONAL WATERSHEDS INITIATIVE

Commissioners received an oral update on International Watershed Initiative projects including progress on the transmittal and media release for the report "How Are We Living with the Red?", progress on the St. Croix International Watershed Board's Spednik Lake research project to determine the impact of historical lake level changes on smallmouth bass habitat, the recent meeting of the Transboundary Hydrographic Data Harmonization Task Force, and the Lower Pembina Task Force Switzer Ridge Survey for post-2009 flood erosion topographical data in support of the 2-D Telemac hydraulic modeling project.

#### UNITED NATIONS ASSOCIATION IN CANADA REQUEST

6. Commissioners considered a request by the United Nations Association in Canada (UNA-Canada) for Commission participation in and financial support for the second Model IJC, which will be held March 10-13, 2010, in Vancouver, British Columbia. Commissioners agreed that the IJC should continue to provide informational and technical assistance to UNA-Canada and agreed that a Commissioner from each section participate in the second Model IJC Conference. Commissioners agreed to provide \$5,000 in funding from the Canadian Section to the UNA-Canada in support of the 2010 Model IJC Conference in Vancouver for specific services and products such as promotional activities or space rental.

### 7. Asian Carp Update

Commissioners received an oral update on the November 19 visit to the Chicago Sanitary and Ship Canal barrier site and on the activities of the Asian Carp Rapid Response Workgroup's December 2-5 fish eradication project operations. Commissioners directed staff to review current federal, state/provincial and local government participation in Asian Carp Rapid Response planning to determine whether a letter from the Commission would be of assistance to the effort.
