SOLEMN DECLARATION OF NEW CANADIAN COMMISSIONERS GORDON WALKER AND BENOIT BOUCHARD

Commissioners Gordon Walker and Benoit Bouchard, having previously been appointed by His Excellency the Governor General-in-Council to be Commissioners on the part of Canada of the International Joint Commission, formally declared that they would faithfully and impartially perform the duties imposed on them under the Boundary Waters Treaty of 1909 in accordance with the provisions set out in Article XII of the said treaty. Following the declarations, fellow Commissioners offered congratulations and welcomes. Commissioners Walker and Bouchard thanked the others for their warm welcomes and noted that they were looking forward to being members of the Commission.
