## 1. APPROVAL OF THE AGENDA

Commissioners approved the agenda for the meeting. Commissioners agreed to move International Souris River Board and Poplar River – Big Muddy Basins agenda items to the end of the agenda. Ultimately the discussion on those agenda items was defered to take place on Friday July 28,2023 during the Commisioner's next in-camera meeting.

#### 2. ACCREDITED OFFICERS OF THE ST. MARY AND MILK RIVERS

Commissioners received an update regarding current conditions on the St. Mary and Milk Rivers and an Accredited Officer decision to allow Canada to accrue a deficit on the Milk River between June 16 and August 5, 2023, with the understanding that the deficit be repaid later this year. Commissioners were supportive of this decision and appreciative of the efforts of the Accredited Officers and of the International St. Mary and Milk Rivers Study Board to work collaboratively to address current conditions in the basin. Commissioners approved sending a letter to the Accredited Officers and to consider a public acknowledgement of the decision later in the year.

#### 3. INDIGENOUS COLLABORATION TEAM ACTIVITIES

Staff updated Commissioners on the activities of the Indigenous Collaboration Team, specifically regarding the planned establishment of an Indigenous Circle of Experts and efforts to enhance Indigenous collaboration on IWI projects. Commissioners were supportive of the activities outlined and asked for some further information and clarity on several points, including the budgetary aspects of the establishment and work of the Indigenous Circle of Experts , before any final decisions are made.

#### 4. COMMUNICATIONS UPDATE

Commissioners were updated on the current activities of the Communications team, including an overview of an upcoming Website Needs Assessment, which is the initial phase of the full redevelopment of the website, about the plans for the semi-annual communications workshop and an update on communications activities planned for the 25<sup>th</sup> anniversary of the International Watersheds Initiative.

## 5. INTERNATIONAL RED RIVER BOARD UPDATE

Staff updated Commissioners on the status of the International Red River Watershed Board's strategic planning efforts and its annual work plan, noting that the work plan delivery to the Commission is likely December 2023 according to the board's co-chairs. Commissioners reiterated their desire to see the completion of the Board's work plan, and noted their support for facilitation of the Board's meeting in August in order to foster more effective Board discussion and planning.

# 6. INTERNATIONAL RAINY-LAKE OF THE WOODS WATERSHED BOARD AND WATER LEVELS COMMITTEE

Commissioners received an update on, and discussed, the potential expansion of the Water Levels Committee to include indigenous members. Commissioners discussed the potential implications of expansion at length and are waiting for a further letter from the Water Levels Committee on this subject prior to making any decisions. Commissioners also received an update from staff on adaptive management projects under consideration by the board for which staff is collaborating, as well as an update on the board's progress to consider making a recommendation to the Commission relative to changing the nomenclature of the High Flood Risk Rule Curve for Rainy Lake in the Commission's supplementary order on Rainy Lake.

## 7. INTERNATIONAL WATERSHEDS INITIATIVE

Staff provided an update on the IWI 25<sup>th</sup> Anniversary Report, and the planning of IWB scoping activities in the Kootenay and Osoyoos basins. Staff noted that the International Kootenay Lake Board of Control has indicated that it believes that IWI scoping should be timed with the review of the 1938 Order, which is currently being planned. The International Osoyoos Lake Board of Control is supportive of IWB scoping activities in the nearer term, and is working with staff to help plan meetings to be held in late summer or early fall.

## 9. GREAT LAKES - ST. LAWRENCE RIVER ADAPTIVE MANAGEMENT COMMITTEE

Commissioners approved the the GLAM Committee's work plan and agreed that it can be posted. Commissioners also discussed how the GLAM Committee can meet other reporting requirements in its directive.

## 10. TAP REPORT COMMUNICATIONS

Commissioners received an update on the development and planned release of the Commission's 2023 Triennial Assessment of Progress Report and supported staff's plan to aim for an early November release of the report.

#### 11. FLOOD AND DROUGHT UPDATE

Staff updated Commissioners on current hydrological and climatic conditions in basins along the US-Canada boundary, with particular attention on continued dry conditions in the western half of the continent and recent flooding in the Lake Champlain-Richelieu River basin.

# International Lake Superior Board of Control (ILSBC)

On May 3, 2023 commissioners approved the Board's request to deviate from Plan 2012 flows from May 2023 through November 2023 and IJC's letter to the ILSBC approving deviation request.

# **US-Canada Global Center in Environmental Prediction**

On May 10, 2023 commissioners approved a draft letter noting IJC support in principle for a US-Canada proposal in partnership for a global centre in environmental prediction

## Science Advisory Board – Science Priority Committee (SAB-SPC)

On May 10, 2023, commissioners approved the following retroactive SAB-RCC appointments:

- A. Dr. Ram Yerubandi as a Canadian member for a three-year period, starting April 1, 2023 and ending March 31, 2026.
- B. Dr. Dale Hoff as a U.S. member for a three-year period, starting May 1, 2023 and ending April 30, 2026.
- C. Dr. Michael Twiss as a binational member for a two-year period, starting March 1, 2023 and ending Feb 28, 2025.

On July 6, 2023, 2023, commissioners approved Nutrients in Lake Erie and Lake Ontario: Synthesis of International Joint Commission Recommendations and Assessment of Domestic Action Plans Report and the associated contractor report for the purposes of transmitting to the Parties and posting to the IJC website; and the associated outreach and engagement plan.

# Great Lakes Water Quality Board (GLWQB)

On May 11, 20223 commissioners approved the appointment of Col. Jason Buursma as the Alternate U.S. Co-Chair of the International Niagara Board of Control, the International Lake Superior Board of Control, and the International Lake Ontario-St. Lawrence River Board for a two-year period, from May 1, 2023, to April 30, 2025, or until a new Alternate U.S. Co-Chair is appointed, whichever comes first.

# International Lake Ontario St. Lawrence River Board and International Niagara Board of Control

On May 12, 2023 Commissioners approved the appointment of Col. Jason Buursma as the Alternate U.S. Co-Chair of the International Niagara Board of Control, the International Lake Superior Board of Control, and the International Lake Ontario-St. Lawrence River Board for a two-year period, from May 1, 2023, to April 30, 2025, or until a new Alternate U.S. Co-Chair is appointed, whichever comes first.

On June 16, 2023 commissioners approved the re-appointment of Ms. Patricia Clavet as member of the International Lake Ontario – St. Lawrence River Board (ILOSLRB) for a period of three years, beginning on June 1, 2023 and ending May 31, 2026.

# International Red River Watershed Board (IRRWB)

On May 23, 2023 commissioners approved the following reappointments to the IRRWB:

- 1. Reappoint Canadian Co-Chair Patrick Cherneski for a 3-year period starting June 1, 2023 and ending May 31, 2026.
- 2. Reappoint Canadian member Dr. Annette Trimbee for a 3-year period starting March 19, 2023, and ending March 18, 2026.
- 3. Reappoint Canadian member Melissa Hotain for a 3-year period starting March 19, 2023, and ending March 18, 2026.
- 4. Reappoint retroactively Canadian member Jason Vanrobaeys for a 3-year period starting August 19, 2022 and ending August 18, 2025.
- 5. Reappoint retroactively US member Nathan Kestner for a 2-year period starting December 12, 2022 and ending December 11, 2024.
- 6. Reappoint U.S member Greg Wiche for a 2-year period starting May 1, 2023 and ending April 30, 2025.
- 7. Reappoint U.S. member April Poitra-Walker for a three-year period starting March 19, 2023 and ending March 18, 2026.

# Milltown Dam Decommissioning

- 3. A letter to the International St. Croix River Watershed Board thanking them for their recent letter and asking them to remain aware of the ongoing progress and impacts of decommissioning.

# International Lake Ontario-St. Lawrence River Board

On June 16, 2023 commissioners approved the re-appointment of Ms. Patricia Clavet as member of the International Lake Ontario – St. Lawrence River Board (ILOSLRB) for a period of three years, beginning on June 1, 2023 and ending May 31, 2026.
